With Accredia, Italy has complied with EC Reg. 765/2008 , which sets the rules on accreditation activities in all EU countries.		
Members	Accredia has 70 members who represent all parties involved in accreditation and conformity assessment activities, among them: 9 Ministries (Enterprises and Made in Italy, Environment and Energy Security, Defense, Infrastructure and Transport, Internal Affairs, University and Research, Labor and Social Policies, Agriculture, Food Sovereignty and Forests, Health), 7 Major national public entities , 2 Standardization bodies (UNI and CEI), 27 business and trade organizations, associations of accredited certification and inspection bodies and testing and calibration laboratories, associations of consultants and consumers and suppliers of public utilities , such as State railways and energy.
