Informative circular DC N°28/2024 - Provisions regarding accreditation for the PAS 24000:2022 certification scheme - Social management system.

## FOREWORD

In September, BSI published PAS 24000:2022 which provides requirements for social management systems.

The PAS, designed according to the ISO Annex SL, specifies the minimum requirements for a social management system (SMS) and the specific criteria for social services enabling their auditability and certifiability.

PAS 24000 defines:

- requirements to ensure the quality of the due diligence process;
- minimum social performance requirements, as defined by the document on the SSCI benchmarking requirements, part III.

The document issued by BSI applies to any organisation, regardless of its type or size, or the products and services it produces or supplies.

The implementation of the system may be of interest to organizations for managing and reporting their performance in the social sphere.

The implementation of the system makes it possible to respond to the expectations of the interested parties also in the medium-long term with a view to continuous improvement in one of the areas of sustainable development.

The social management system comprises the policies, processes and procedures used by an organization to ensure the implementation of the actions required to achieve its social objectives. These objectives must ensure fair treatment of workers and a safe working environment that does not harm their health and that complies with legislative and normative requirements.

The document provides that the organization refers both to the "minimum salary", established according to the collective agreement, and to the "decent salary", i.e. the remuneration received for ordinary work, established by contract, sufficient to allow the worker to sustain a standard of decent life for her/him and her/his family.

In fact, PAS 24000 provides that the organization pays its workers according to the "decent wage", in cases where this is higher than the "minimum wage".

The PAS 24000 uses the process approach, the Plan-Do-Check-Act (PDCA) cycle and the principle of risk based thinking.

The process approach enables an organization to plan processes and their interactions in order to define roles and responsibilities within it.

The PDCA cycle enables the organization to ensure that processes are managed and adequately resourced and that opportunities for improvement are identified and implemented.

Risk based thinking enables an organization to determine the factors that could affect the achievement of planned results, to implement advance controls, to minimize negative effects and to maximise the benefits of opportunities.

The PDCA cycle applied to the social management system requires the organization to:

- plan: determine and evaluate social risks and opportunities and establish the social objectives and processes necessary to obtain results in accordance with the organization's social policy;
- do: implement processes as planned;
- check: monitor and measure processes with regard to social policy, including the organization's social commitments and objectives, and report the results;
- act: take actions to correct deviations from expected results and continuously improve social performance to achieve expected results.

# **PROCESS OF ACCREDITATION**

Various cases may be presented, based on the ACCREDIA accreditations already possessed by the CB that applies for accreditation or extension.

The requirements of RG-01 and RG-01-01 for the granting of accreditation and extension remain unchanged.



Certification and Inspection Department <u>CBs already accredited to ISO/IEC 17021-1 do not need to have already issued certificates in this scheme to apply for an extension of accreditation.</u>

The accreditation certificate does not indicate the relative accreditation sectors.

If the CB already has accreditations issued by other bodies, an assessment must be conducted on a case-by-case basis, based on the applicable EA/IAF MLA agreements.

- DA-01 Accreditation application for CBs.

## MAINTENANCE OF ACCREDITATION

To maintain accreditation, throughout the accreditation cycle, except for special situations (e.g. management of complaints and reports, changes to the certification scheme, changes in the corporate structure of the Body, involvement in legal cases...), the following assessments shall be undertaken:

- if the CB has issued up to 50 certificates in the certification scheme, 1 witness assessment and 1 on-site assessment specific to this scheme must be performed; however, in the case of a small number of certificates (<10), it is possible to perform only one assessment in the cycle (on-site or witness);
- if the CB has issued between 51 and 200 certificates in the certification scheme, 2 witness assessments and 1 on-site assessment specific to this scheme must be performed;
- if the CB has issued more than 200 certificates in the scheme, 2 witness assessments and 2 on-site assessments must be performed for this scheme.

On an annual basis ACCREDIA shall perform an assessment at the CB's head office to assess compliance with ISO/IEC 17021-1.
